
Marie-France Comeau, 38, a corporal in the Canadian Forces, was found murdered in her Brighton, Ontario, home on November 25, 2009. Williams later confessed to the grisly sex slaying of the dedicated soldier who had served under his command.





Jessica Elizabeth Lloyd, 27, was reported missing by her family on January 29, 2010. She was later found murdered, her body discarded in a wooded area on the outskirts of Tweed, Ontario. Colonel Williams confessed to having raped, tormented, and strangled her over a period of almost twenty-four hours, and personally led police to the remote site where he had dumped her remains.
